
EMA to review persistence of side effects known to occur with quinolone and fluoroquinolone antibiotics

Information on quinolone and fluoroquinolone antibiotics

- Quinolones and fluoroquinolones are a class of broad spectrum antibiotics that are active against so-called Gram-negative and Gram-positive bacteria.
- Quinolones and fluoroquinolones are widely prescribed in the EU and are important options for treating bacterial infections including serious and life-threatening infections.

In Malta four different fluoroquinolones antibiotics are authorised through national procedures. These are ciprofloxacin, levofloxacin, moxifloxacin and norfloxacin. For more details on fluoroquinolone containing products authorised in Malta refer to Annex 1 at the end of this document.

EMA's review to focus on long-lasting effects mainly affecting musculoskeletal and nervous systems

The European Medicines Agency (EMA) is reviewing systemic and inhaled quinolone and fluoroquinolone antibiotics to evaluate the persistence of serious side effects mainly affecting muscles, joints and the nervous system. These side effects are of particular importance when the medicines are used for less severe infections.

- The review concerns only inhaled medicines and medicines given systemically (by mouth or injection). Topical medicines, such as those applied directly to the skin, eyes or ears, are not included in this review.
- The review was initiated on 9 February 2017 at the request of German medicines authority (BfArM), under [Article 31 of Directive 2001/83/EC](#) and follows reports of long-lasting side effects in the German national safety database and the published literature.
- There has been no previous EU-wide review specifically focusing on the persistence of the side effects, but the side effects themselves are known and are covered in the EU prescribing information for these medicines.

The EMA's Pharmacovigilance Risk Assessment Committee (PRAC) will now evaluate all available data and determine whether there is a need to introduce new measures to minimise these risks or modify how the medicines are used. The PRAC recommendations will then be sent to the Committee for Medicinal Products for Human Use (CHMP), responsible for questions concerning medicines for human use, which will adopt the Agency's opinion. The final stage of the review procedure is the adoption by the European Commission of a legally binding decision applicable in all EU Member States.

- Until the final decision is published healthcare professionals using these medicines should continue to follow the official prescribing information.
