Details of discovery: On 20th January 2017 a delivery of 4 boxes containing NutropinAQ took place from Ipsen Pharma Biotech (manufacturer) (for Ipsen Pharma (France)) to the warehouse in Belgium. Upon receipt at the warehouse, a random check of one		

box was performed. This box was complete. However, at the end of March, during the preparation of an order, the warehouse identified that 2 of the 4 boxes were incomplete, a shortage of 101 packs of 3 cartridges NutropinAQ 10mg/2ml. The warehouse informed Ipsen Pharma NV. An investigation is ongoing. There is a potential risk that the 101 missing packs of 3 cartridges NutropinAQ 10mg/2ml are circulating on the illegal market.
