After initial investigations carried out by Guardia Civil and Health authorities in Pontevedra and Alicante, as part of PANGEA XI Operation, the products were submitted to our Agency and analysed by the Official Medicines Control Laboratory (OMCL) of AEMPS and found to contain: AUGEBIT tablets: sildenafil, SWEET END sachets: tadalafil, OVER-X capsules: tadalafil (Batch 0032018) and sildenafil (Batch L002912), INFINITUM tablets: sildenafil, POWERUP capsules: tadalafil.
