Circumstances Thai authorities seized controlled medical and health products and equipment intended for illicit trade during the COVID-19 pandemic, including hand sanitizers, mask sanitizers, face masks, thermometers, and personal protective equipment (PPE) worth more than THB 114 million (USD 3,557,000).

modus operandi:

Description of Offenders exploited the COVID-19 pandemic situation to run the illicit trade of controlled medical and health products and equipment by organizing and contacting manufacturers that produce devices, products, and equipment related to medical and health control.

> The Consumer Protection Police Division (under the Royal Thai Police), in cooperation with the Food and Drug Administration, Ministry of Public Health, and Department of Internal Trade, seized the following items:

- 473,974 bottle of hand-gel sanitizers
- 160,000 mask sanitizers
- 81,600 face masks
- 1,280 thermometers
- 4,000 items of personal protective equipment (PPE)

The seized items are worth THB 114 million (USD 3,557,000).

The investigation revealed that 2 offenders imported the above-mentioned seized items, then organized to have them stored in 5 warehouses and attempted to sell them in online markets and elsewhere to make profit.


